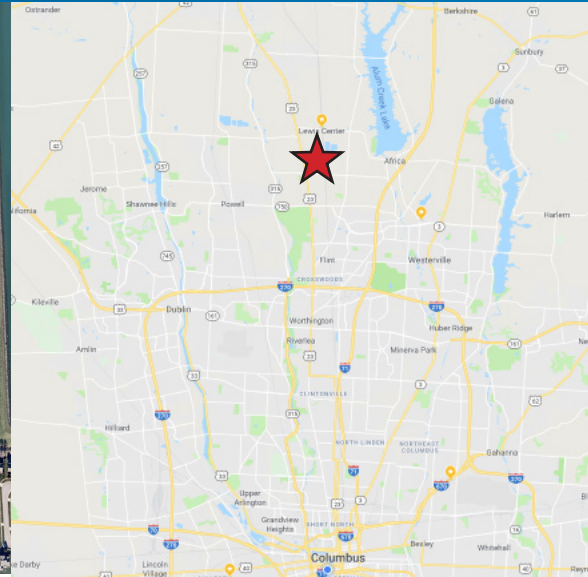

These “shovel ready” industrial/flex land sites are located at the crossroads of Green Meadows Drive and Corduroy Road, less than ½ mile east of US-23 on the north side of Columbus. The sites offer excellent access to freeways. The land is surrounded by several newer commercial uses which provide a first class image. The property is eligible for sales tax exemption on construction materials through the Finance Authority and also enjoys a 15-year tax abatement on real property improvements.

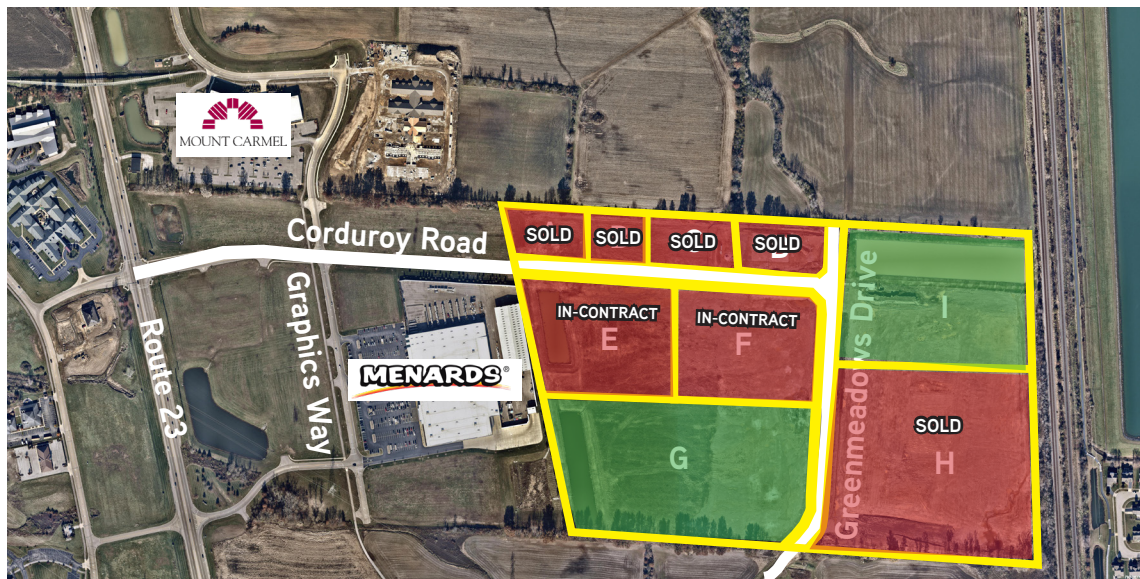

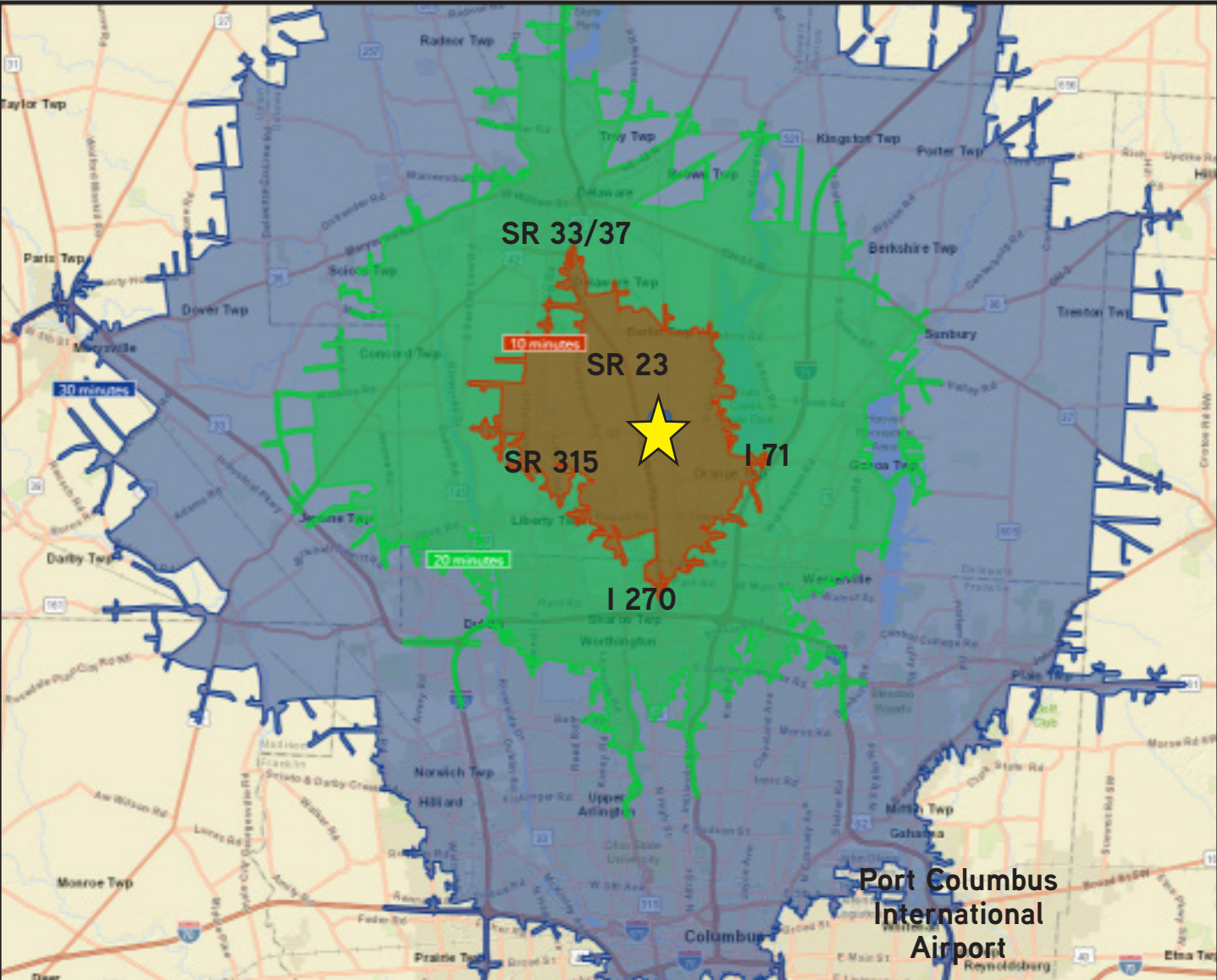


## Area Amenities Map
